MOTION FOR AN EXTENSION OF TIME

Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Johnathan Devon Moss with the Court of Appeals on July 1, 2019. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Richard E. Tedford v. The State with this Court on July 1, 2019. Counsel filed the initial brief of appellant and designation of matter in the case of The State v. Jarnelle Ladarius Ervin with the Court of Appeals on June 12, 2019.


4. Counsel makes this request in good faith and not for purpose of delay.


