Dear Chief Justice Beatty and Clerk of Court Shearouse:

I am serving as the Deputy Attorney General of the Criminal Division of the Attorney General's Office with supervisory responsibilities over litigation within the office concerning the Sexual Violent Predator Act and its appeals within the office. During the March 29, 2018 oral argument in this case, a justice of the court made inquiry about the timing and existence of a conviction of Michael Darnell Thomas (whose March 15, 2014 arrest warrant was used by the State at the hearing to impeach Dr. Gehle). The facts about the timing of the conviction were not part of the appellate record in the case nor before the trial court. The Senior Assistant Deputy Attorney General correctly responded that Mr. Thomas had been convicted on that warrant, but relied upon sentencing data in making her response to the Court about the timing of the conviction. However, matters that followed need to be addressed.

Because of the significance of the response of one of the justices concerning the existence of the conviction and the diligence of this Office in the asserted failure to present the conviction at the original 2014 trial instead of the arrest warrant, we reviewed the public records to insure the correctness of the information provided to the Court. As a matter of public record which this Court can take judicial notice, Michael Darnell Thomas was

convicted on **April 26, 2016** by a guilty plea before Judge DeAndrea Benjamin for criminal sexual conduct -first degree on Indictment 2014-GS-40-04538 (Warrant 2014A4021600851) among other charges and sentenced to thirty years with credit for time served of 747 days. This conviction occurred *after* the SVP trial of the Kenneth Campbell case before Judge McMahon on **September 8, 2014**. Therefore, inasmuch as the 2016 conviction did not exist at the time of the 2014 SVP trial, there was no lack of diligence on the part of the Assistant Attorney General in failing to present the non-existent conviction matter in lieu of the existing arrest warrant.

As the Court is aware, Senior Assistant Deputy Attorney General Shupe has already advised this Court of a misstatement she made during her oral argument by letter. A review of the Public Index of South Carolina Department of Corrections Inmate records on the criminal sexual conduct 1st degree charge reflects a sentence "start date" of "April 10, 2014" - a date before the September 2014 trial of Mr. Crawford rather than the actual conviction date of April 26, 2016 - a date after that trial. I am enclosing a copy of the SCDC Inmate Record run on March 28, 2018 (the day before the oral argument consistent with her response) as well as the plea and sentencing sheet that we have subsequently received. Although the SCDC data appellate counsel had and relied upon supports and is consistent with her response to the Court's question, the corrected fact is that the conviction actually occurred subsequent to the challenged trial. Nevertheless, this fact does not support any statement concerning a lack of diligence on the part of this office's attorneys at the Campbell SVP trial.

I trust this Court will find this letter removes the basis of the public comment towards those attorneys about the failure to present the non-existent conviction data in the 2014 trial. I am providing a copy of the material to opposing counsel and request this letter is also provided to the members of the Court. Again, the purpose of this letter is not intended to re-argue the merits of the position, but to correct and clarify statements made concerning collateral matters at the oral argument. Thank you for your time and consideration.

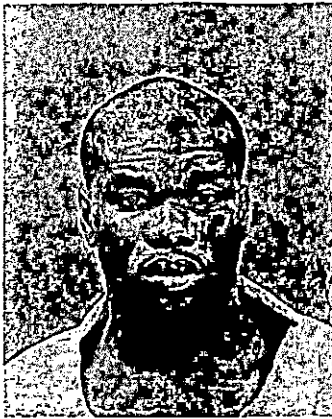
