MOTION FOR AN EXTENSION OF TIME

previously granted and the order in which counsel attempts to manage his caseload, counsel hopes that no further extension requests will be required.



Counsel filed the Anders brief of appellant and designation of matter in the case of The State of South Carolina v. Drake Edward Campbell with the Court of Appeals on July 16, 2019. Counsel filed the petition for rehearing in the case of State v. Aaron Young, Sr. with the Court of Appeals on July 11, 2019. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Nathaniel Mitchell v. The State of South Carolina with this Court on July 1, 2019. Counsel filed the petition for rehearing in the case of State v. Jose Reyes Reyes with the Court of Appeals on June 27, 2019. 4. Counsel makes this request in good faith and not for purpose of delay.


5. Counsel for the Attorney General's office consents to this request as shown by signature below.
