Motion to Extend Time to File Record on Appeal Outside of Rule 210 Time Limits

Comes now Appellants' counsel, and respectfully moves with consent of Appellee's counsel, to file the Record of Appeal Outside of Deadlines of Rule 210 the South Carolina Appellate Rules. In support of this motion, Appellants' counsel states as follows:

1. This amended action was timely filed on February 13, 2019 after the final order of dismissal was filed on January 15, 2019.
2. Appellant's counsel and Appellee's counsel have timely filed initial briefs in this case and the current deadline to file the Record of Appeal in this case is currently set for August 19, 2019.
3. Appellants' counsel is respectfully requesting a fifteen (15) day extension of the time set to file the Record on Appeal. This would extend the filing deadline to September 3, 2019. Appellants' counsel has diligently worked with Appellee's counsel to prepare the Record on Appeal, but counsel requires additional time due to the voluminous Record as well as Appellants' counsel's other legal obligations.
