I am in receipt of your August 6, 2019, stating that the Court's records do not reflect that I am counsel of record for the appellants in the above-referenced matter. I spoke with the case manager for this file today and was instructed to prepare this correspondence to clarify this matter so that an order of dismissal may be issued. When the appeal of this case was filed in 2017, Daniel Addison and David Bornemann were the attorneys of record for Advanced Disposal Services. In fact, all three of us were employed by the law firm of Hedrick Gardner Kincheloe & Garofalo. Mr. Addison and Mr. Bornemann subsequently left the firm, and Advanced Disposal requested this case remain with Hedrick Gardner with me as counsel of record.
