STATEMENT PURSUANT TO RULE 203(D)(1)(b)(IV)

Appellant pled guilty pursuant to *N.C. vs. Alford* on August 6, 2019. This matter was called to trial on August 5, 2019 and two days of pre-trial matters ensued. The Appellant raised suppression issues pursuant to Rule 404(b) and *Lyles* to preclude the jury from hearing allegations of sexual misconduct that allegedly occurred in North Carolina. These motions were denied by the trial court. The Appellant moved for a hearing pursuant to S.C. Ann. § 16-3-659.1 to have the jury hear the sexual history of the victim, which was denied by the trial court. Subsequent to the pre-trial matters and before the opening statements, the Appellant pled guilty pursuant to *N.C. vs. Alford*.






