

NOTICE OF APPEAL

Joe Tajharey Natron McFadden appeals his guilty plea and sentence in the above captioned matter and Judge Cothran's rulings on his Motion to Reconsider Sentence. The guilty plea was entered before the Honorable Kristi F. Curtis on December 19, 2018, and a sealed sentence was imposed by the Honorable R. Ferrell Cothran, Jr., on January 22, 2019. Thereafter, on June 20, 2019, the sentences were unsealed and put on the record by the Honorable George M. McFaddin, Jr. At that time, the Defendant moved to have his sentences reconsidered which Judge McFaddin deferred to be heard before Judge Cothran. On August 7, 2019, The Honorable R. Ferrell Cothran, Jr., heard the Appellant's Motion to Reconsider Sentence and amended the sentence on Indictment number 2018-GS-14-0157 from a consecutive five year sentence to a concurrent five year sentence. No further relief was granted.
