
**NOTICE OF APPEAL

Coltex, 285 S.C. 213, 329 S.E.2d 736 (1985) (new trial because of error of law); Simms v. Phillips, 46 S.C. 149, 24 S.E. 87 (1896) (subject matter jurisdiction); Nat. Exchange Bank v. Stelling, 32 S.C. 102, 10 S.E. 766 (1890) (personal jurisdiction); Godley v. Uniroyal, Inc., 278 S.C. 571, 300 S.E.2d 78 (1983).


