Counsel is preparing and consulting with Chief Appellate Defender, Robert M. Dudek, on the petition for writ of certiorari and accompanying appendix in the case of Greg K. Isaac v. The State which he plans to file with the Supreme Court in the upcoming weeks.


3. This request is made in good faith, and not for purposes of delay.
