On 7-8-19, this Court submitted a letter to me stating that I had forty-five  
(45) days from that date to submit a pro se response to the Johnson petition  
that my appellate counsel filed with this Court. I did not receive this letter until  
August 5, 2019. On 4-15-18, then Governor Nikki Haley issued a statewide lockdown  
for all level 2 and level 3 institutions. In August 2018, statewide lockdown was  
lifted. However, the Wateree Unit at Broad River C.I. was left on 24/7 permanent  
lockdown status and is still on 24/7 permanent lockdown. Furthermore, I have been -  
and still is - denied access to the law library, satellite law computer, and legal  
supplies. Broad River C.I. don't have a permanent mailroom clerk, the mailroom  
clerk don't come to the Wateree Unit on a daily basis, nor do Broad River  
C.I. staff and administrative officials allow me to go ~~to~~ the mailroom.

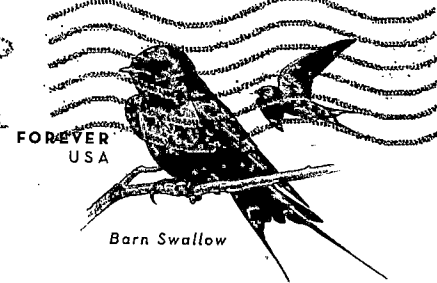
