
The Petition is due on September 5, 2019, by our calculations.



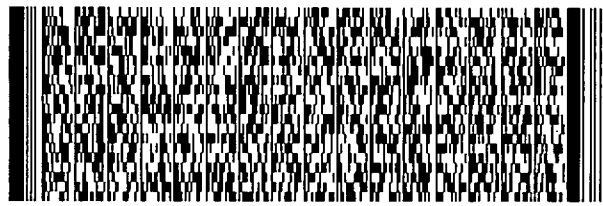

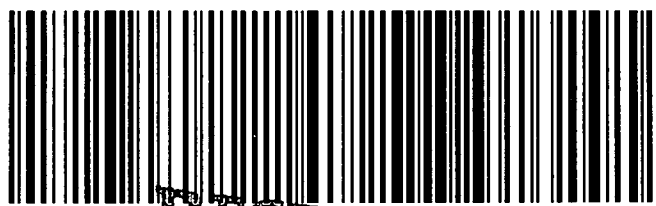
