MOTION FOR AN EXTENSION OF TIME


1. The petition for writ of certiorari and appendix are due to be served and filed with the Court today.

On July 26, 2019, counsel filed a petition for writ of certiorari and accompanying appendix in Matthew C. Dwyer v. The State with the Supreme Court. On July 22, 2019, counsel filed the petition for writ of certiorari to the Court of Appeals in The State v. Felix Kotowski with the Supreme Court. On July 18, 2019, counsel filed the Anders brief of appellant and record on appeal in In the Matter of the Care and Treatment of Mark Rainey with the Court of Appeals. On July 11, 2019, counsel filed the initial brief of appellant and designation of matter in The State v. Dale Elroy Mathis with the Court of Appeals. On June 28, 2019, counsel filed the petition for writ of certiorari to the Court of Appeals in The State v. Justin Antonio Butler with the Supreme Court. On June 26, 2019, counsel filed the initial brief of appellant and designation of matter in The State v. Demorris Octswavious Andrews with the Court of Appeals.


4. Counsel makes this request in good faith and not for purpose of delay.




