12 involved greatly appreciates your patience as you did that.
13 Thank you very much.

14 (WHEREUPON, the jury was released and exited the
15 courtroom at 5:18 p.m.)

16 THE COURT (BROWN): All right. Defense counsel, prior
17 to the jury coming back in, requested ten days for any post-
18 trial motions. I'll give each party ten days to file
19 whatever post-trial motions they seem -- or they deem
20 appropriate.

21 If the defense files certain motions, I'll give
22 plaintiff's counsel ten days to respond. Whatever motions
23 plaintiff's counsel may file, likewise, we'll give defense
24 counsel ten days to respond to those. Okay?

25 MR. RIORDAN: Thank you, Your Honor and Your Honor.
