MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION FOR WRIT OF
CERTIORARI AND APPENDIX

Counsel for petitioner respectfully requests an extension of thirty (30) days in which to file the petition for writ of certiorari and appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a second request for an extension. In support of this request, counsel shows:

1. The petition for writ of certiorari and appendix are due to be served and filed with the Court today.
2. Counsel for petitioner respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the number of extensions previously granted and the order in which counsel attempts to manage his caseload, counsel hopes that no further extension requests will be required.

Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Joseph O. Morant v. The State with this Court on July 31, 2019. Counsel filed the Anders brief of appellant and designation of matter in the case of The State v. Wesley Lamonte Givens with the Court of Appeals on July 29, 2019. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Jamie Mishoe v. The State with this Court on July 10, 2019. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of William R. Pearson v. The State with this Court on July 8, 2019. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Robert A. Baker v. The State with this Court on July 8, 2019.

4. Counsel makes this request in good faith and not for purpose of delay.

5. Counsel for the Attorney General's office has been informed of this request.






