**PETITION FOR EXTENSION TO FILE
INITIAL BRIEF OF APPELLANT AND
DESIGNATION OF MATTER**

Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Robert Lee Wright v. The State in the Supreme Court on July 8, 2019. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Travis Latrell Lawrence in the Court of Appeals on July 5, 2019. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Willie Gunter v. The State in the Supreme Court on June 24, 2019. Counsel filed the Anders brief of appellant and Record on Appeal in the case of State v. Treshawn Markeese Jenkins in the Court of Appeals on June 20, 2019. Counsel filed the initial brief of appellant and designation of matter in the case of State v. James Elbert Daniels, Jr. in the Court of Appeals on June 7, 2019. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Tyrone Anthony Wallace, Jr. in the Court of Appeals on June 3, 2019.

3. This request is made in good faith, and not for purposes of delay.


4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.


