5. Defendant requested the Appeal be filed.

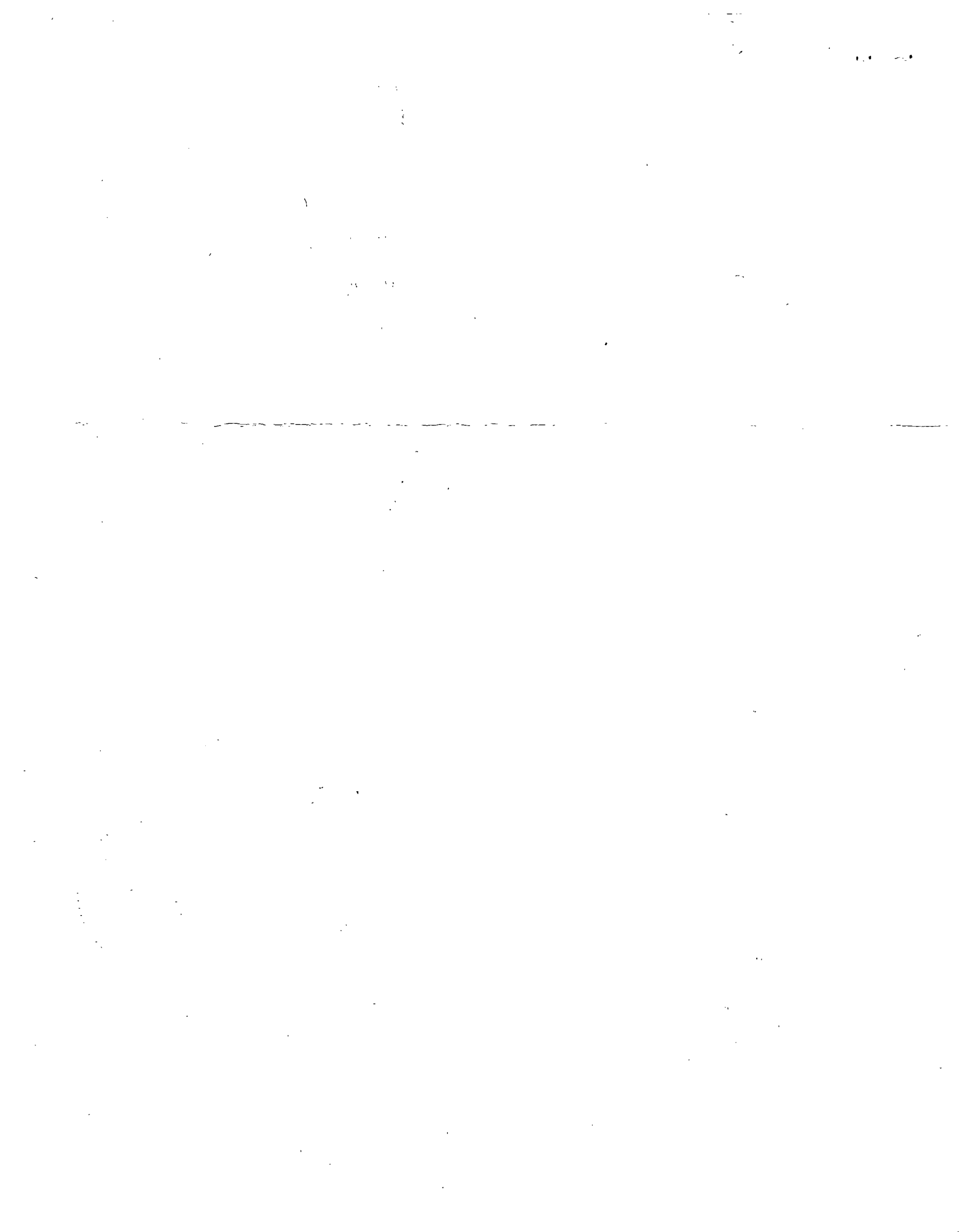

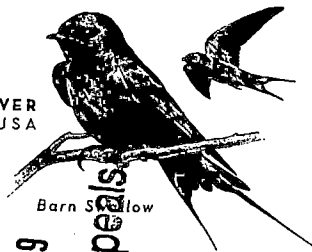
