MOTION FOR AN EXTENSION OF TIME



Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Jamie Mishoe v. The State with this Court on July 10, 2019. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of William R. Pearson v. The State with this Court on July 8, 2019. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Robert A. Baker v. The State with this Court on July 8, 2019.

4. Counsel makes this request in good faith and not for purpose of delay.

5. Counsel for the Attorney General's office has been informed of this request.






