The Petition will be amended and an appendix will be included as soon as possible. The Petition applies to all orders and letters from the SC Court of Appeals since 5 April 2018.


Additionally, be informed there are outstanding motions before the Court of Appeals that have yet to be ruled on / properly ruled on in these matters.

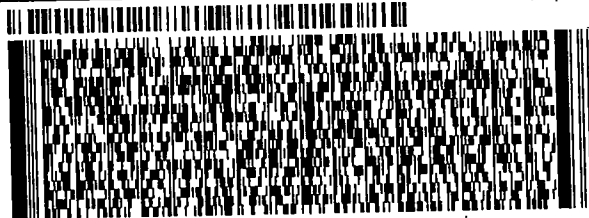
