JUDGEMENT


Comes now, defendant, Richard Grounell, Pro SE, makes a motion granting dismissal of case #
08-CP-23-2331.

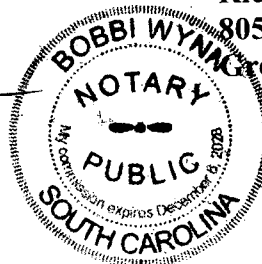
1. In my opinion the suit is Frivolous, Harassing and full of Deception to the Higher Courts.
2. Two Judges, not Juries have Ruled that I Owe Garry Hoyt Nothing. Second hand information has told me that the Judges consulted with other Judges and Lawyers and they agree with the Judges Ruling.
3. I lost my capital investment in this venture.

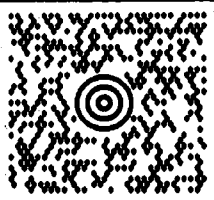

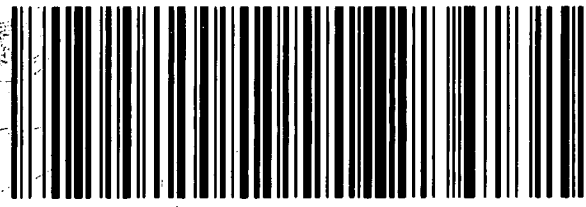
