NOTICE OF APPEAL


Appellant, Gary Clark, Jr., appeals the Order of the Appellate Panel of the South Carolina Workers' Compensation Commission dated August 19, 2019, on the following grounds:

1. THE WORKERS' COMPENSATION COMMISSION ERRED IN FAILING TO SET ASIDE THE EMPLOYER/CARRIER'S CLAIM FOR SUBROGATION PURSUANT TO S.C. CODE §42-1-560.
2. THE WORKERS' COMPENSATION COMMISSION ERRED IN FAILING TO RULE UPON CLAIMANT'S MOTION TO SET ASIDE THE EMPLOYER/CARRIER'S SUBROGATION CLAIM PURSUANT TO S.C. CODE §42-1-560.
3. THE WORKERS' COMPENSATION COMMISSION ERRED IN DISMISSING AS INTERLOCUTORY CLAIMANT'S APPEAL OF THE SINGLE COMMISSIONER'S DENIAL OF CLAIMANT'S MOTION TO SET ASIDE THE EMPLOYER/CARRIER'S SUBROGATION CLAIM PURSUANT TO S.C. CODE §42-1-560.



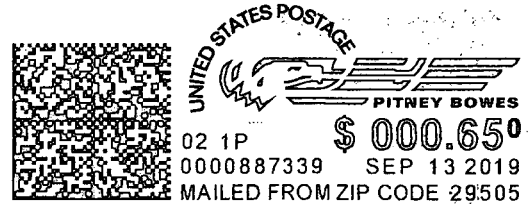
