OF COMPETENT COUNSEL ON THIS APPEAL.

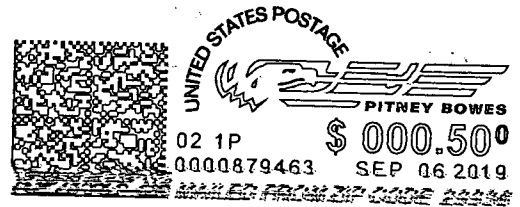
