
MOTION



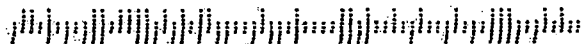
