
MOTION FOR WITHDRAWAL OF COUNSEL





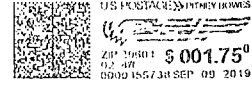
