In regards to lack of fair legal counsel, situations induced while incarcerated along with court proceedings during my plea of guilty.

First I would like to explain verifiable, factual circumstances surrounding charges at hand. Being arrested for 2nd degree burglary & petty theft.

After three months of incarceration of 6 months total I still had not seen or spoke with any public defender, this prompted me to have my family contact their office and leave a message for Ms. Gibbs to please

file my motion of discovery and speedy trial. I still had not received speedy trial the whole time sailed, multiple attempts to miss Gibbs to help me get proof I stayed at hotel and worked there was in paycheck form in my property at bail and she didn't help me obtain the articles nor did she convey my facts to the prosecution, of the facts I were telling her about tools that were left out were returned by my efforts the next day.

Ms. Gibbs wouldn't check the legal citizenship status of supposed victims either, I had many reasons to believe they were working and living in the U.S. illegally. There were many false statements made by them to enhance my sentencing to be stealing tools. Stating they were working and went on break at 10:30 pm (no work allowed after 8pm in open hotel)

(stating they seen and chased me)

(stating they seen me smoking with a guy outside moments before tools were gone)

This last one actually merits a charge of theft not burglary 2nd, though I was securing and returned left out tools in public area.

I felt like I was being pushed into only being able to take 2 yrs prison or drug court from my council Ms. Gibbs, as I received no better option or plea offer after 6 month 5th level
