A lesser charge was offered and

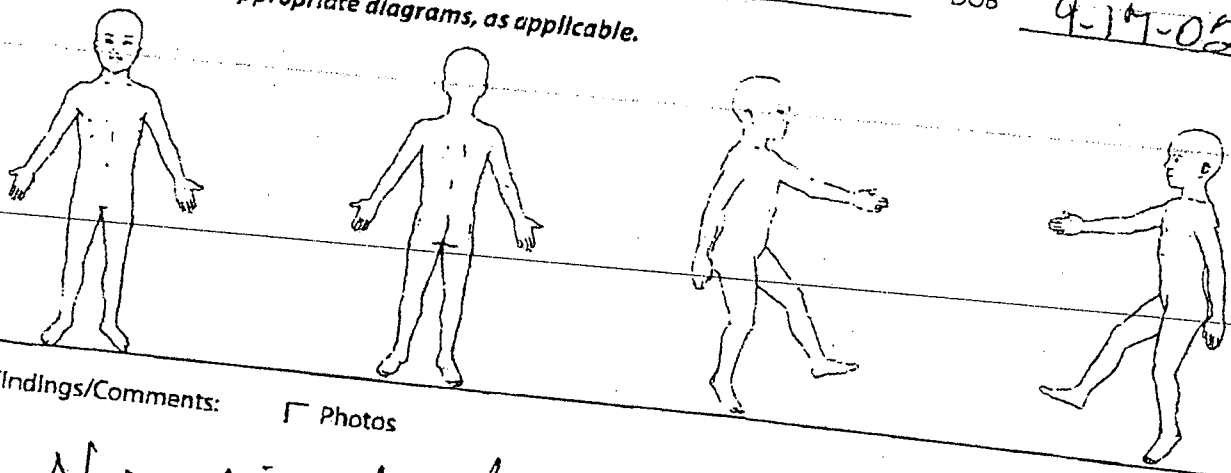

I have proof of the State And the Accuser Adult Family living, criminal record And perjury to help keep A wrongful conviction.

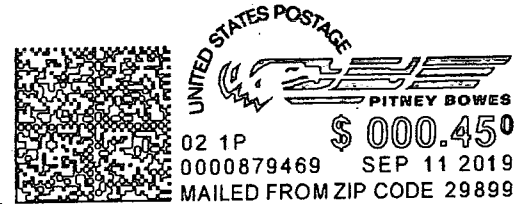
