Appellant is currently litigating in four separate courts including this court:


- U.S. court of appeals, fourth Circuit (Appeal No. 19-7185)



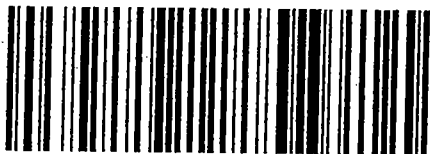

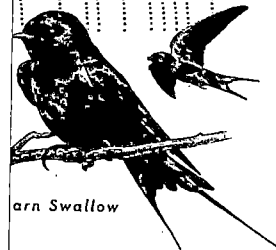
