NOTICE OF APPEAL<sup>1</sup>

Fisher Controls International LLC (“Fisher”) appeals (1) the order filed November 7, 2017, approving Plaintiff’s request for approval of wrongful death and survival settlements; (2) the order filed January 7, 2019, granting Plaintiff’s motion for protection against the trial preservation deposition of Dr. Timothy Oury; (3) the order filed January 7, 2019, denying Fisher’s motion to reconsider the court’s order granting Plaintiff’s motion for protection; (4) the order filed January 11, 2019, granting Plaintiff’s motion to strike defendants’ tissue digestion and preclude any evidence or testimony based on defendants’ tissue digestion; (5) the order filed August 22, 2019,

denying Fisher's motions for judgment notwithstanding the verdict, new trial, and new trial *nisi remittitur*, and granting in part and denying in part Fisher's motion for setoff; (6) the order filed August 22, 2019, granting Plaintiff's motion for sanctions against Fisher; and (7) the jury verdict and related judgment and the evidentiary and other rulings adverse to Fisher during trial. Copies of the orders, verdict form, and judgment are attached hereto. Fisher received written notice of the orders denying its post-trial motions and granting sanctions against it on August 22, 2019.
