UNDER RULE 222**





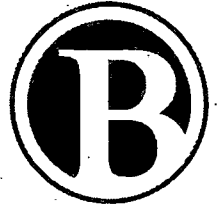
