





WHEREFORE:



California, 422 U.S. 808, 45 L.Ed.2d 562, 95 S.Ct. 2525 (1975); Batchelor v. Cain, 682 F.3d 400, (CA.5 2012); and, Bribiesca v. Galaza, 215 F.3d 1015 (CA.9 2000).

Further, petitioner understands "the dangers and disadvantages of self representation...", U.S. v. Moskovits, 86 F.3d 1303 (CA.3 1996).

Lastly, petitioner asserts his retention of the right to substitute counsel of choice at will. U.S. v. Gonzalez-Lopez, 548 U.S. 140, 165 L.Ed.2d 409, 126 S.Ct. 2557 (2006); and, Wheat v. U.S., 486 U.S. 153, 100 L.Ed.2d 140, 108 S.Ct. 1692 (1988).

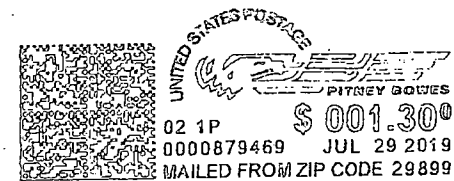
