4) Due to this 2006 Ford F-350 (vin # 1FTWW31P86ED61140) being apart of my criminal case as need evidence because of Deputy's report of what he could see through heavily tinted windows and his site of the passenger side tires hitting the right side lane divider while driving behind the (case number # 2017 A2330206510, 2017 A2330206508)

5) Under the 14th amendment the state can not tak^{ing} or forfeiture on property that is not based on a felony conviction (Due Proceeds laws) and the 8th amendment excessive Fines clause protects against government retribitant at all levels

6) The Appellant has many good issues in his of appeal from the lower Circuit court ruling.
