Dear Sir,

I am writing in concerns to the Order of Dismissal of Appellate Case No.2019-001128, in which I received on 9-25-19. In the Order it states that "Rimittitur will be sent as provided by Rule 221(b),SCACR." My problem is that I don not know what Rule 221(b),SCACR encompasses, and therefore, don't know how to properly respond to it.

I have, on 9-25-19, placed a message on the institutional kiosk machine requesting to be allowed to attend the prison law library to research the rule. But due to an inadequately ran law library headed by an untrained librarian coupled with the fact that the institution still remains on 24 hour 7 days a week lock down for those inmates without a job or school, I am unable to attend the law library.

Therefore, I am requesting that, if there is a time deadline to make any type of response or act, that it please be stayed or extended until which time that I am allowed to get knowledge of what Rule 221(b),SCACR encompasses, either by institutional law library attendance or by a copy of the rule being sent from this court.

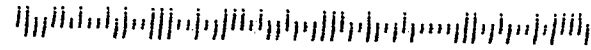

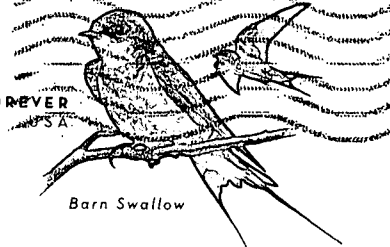

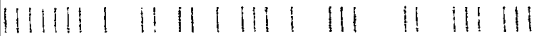
