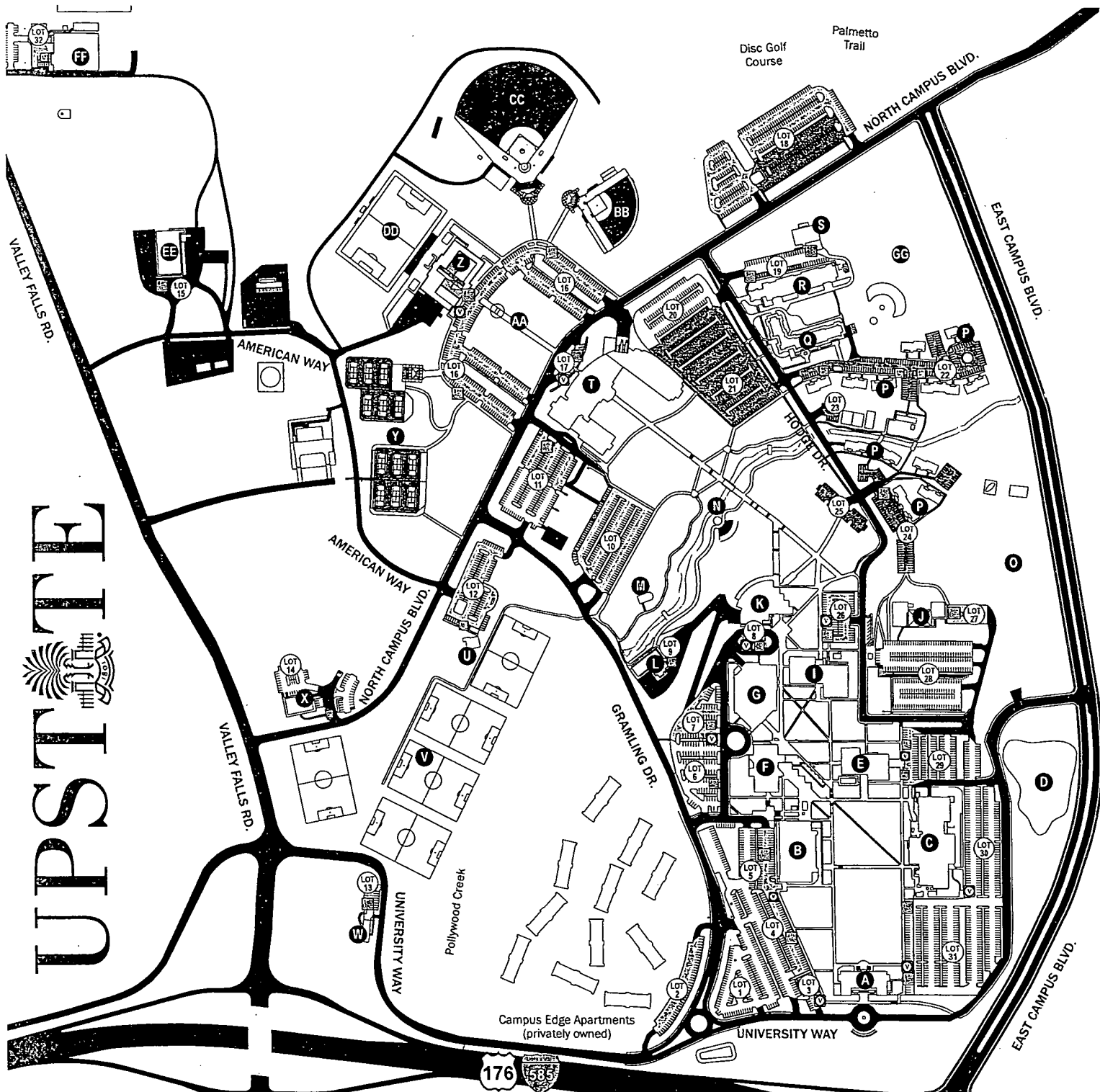
Enclosed is a copy of a campus map that should assist you with parking which will be located in Lot 7.
