
This case is scheduled for oral argument at 9:30 a.m. on Tuesday, October 29, 2019.

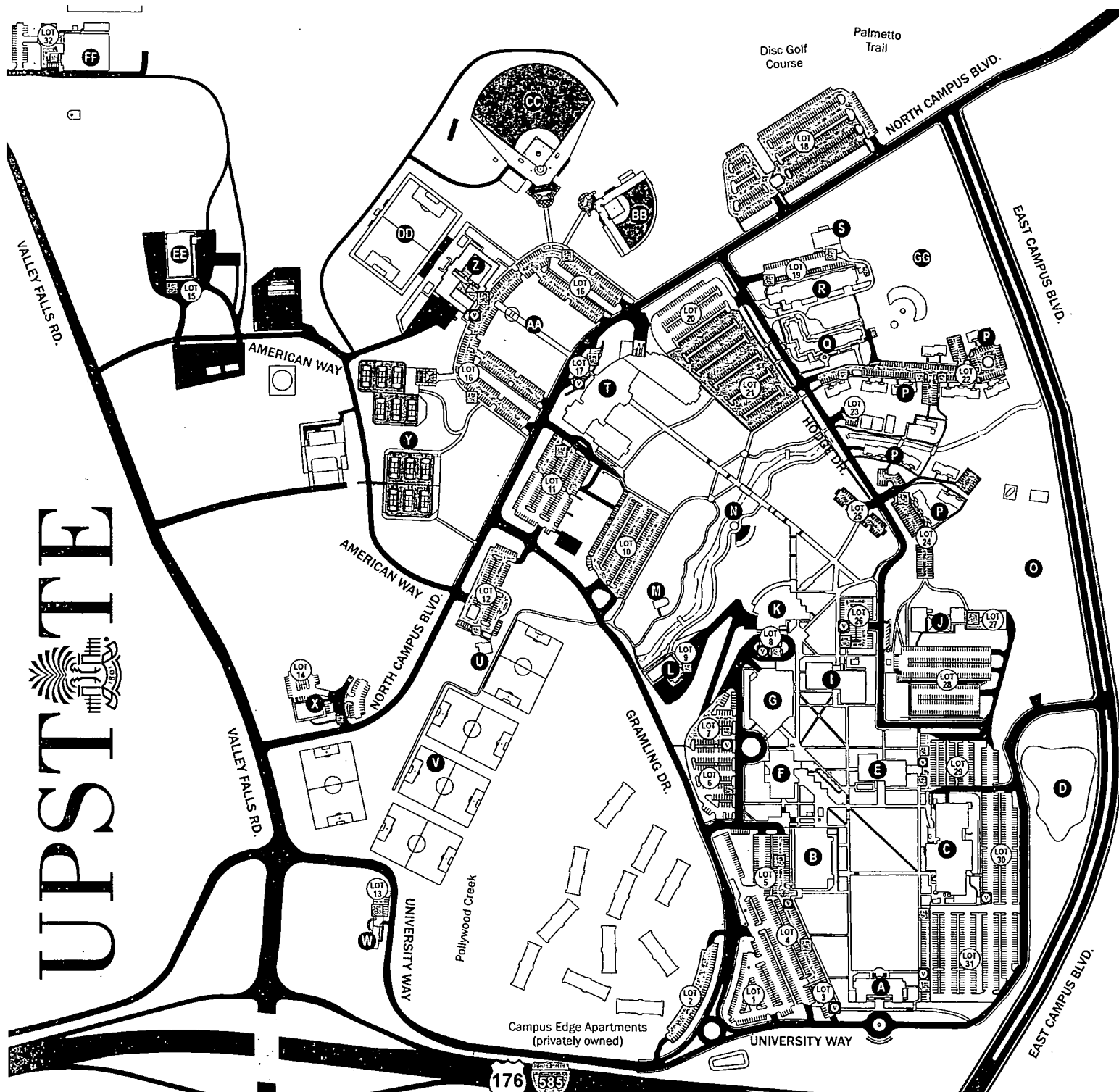
Enclosed is a copy of a campus map that should assist you with parking which will be located in Lot 7.
