
Dear Mr. Smalls:

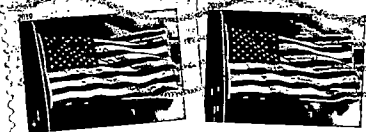
