**RESPONDENT RYAN NOEL OLIVER'S MOTION
TO STAY DEADLINE FOR FILING INITIAL BRIEF**

Respondent requests that the deadline for the submission of his Initial Brief, as well as all subsequent deadlines set forth in the South Carolina Rules of Appellate Procedure be stayed and held in abeyance pending a ruling by this Court on Respondent's Motion to Strike Portions of Appellant's Designated Matter in the Record on Appeal, filed July 30, 2019. 
