I ask the court to accept the information provided in regards to Case No. 2017-002386, Windy Hill MHP LLC as the Respondent v Chris Holcombe as the Appellant.

I received the letter from Mr. Gleaton in regards to the motion filed with the Court about the case. I ask the Court to continue to accept the motion that was filed dated June 5, 2019. Below is a list of the reasons for asking the Court to accept and grant the motion:

1. If Mr. Gleaton would have observed the handicap and vulnerable adult laws, the case would not have been drawn out as far as it has come.
2. If Mr. Gleaton would have checked the credentials of Mrs. Wagner that was claiming to be a property manager for Windy Hill MHP LLC; he would have found that she was not licensed to be a Property Manager in the state of South Carolina.
3. Throughout this process I have not been able to find reasonable legal counsel. Everyone one that I spoke with informed me that this case was a unique case and that could not help me. Yes I did finally get the attorney from SC Legal Services; he did not represent me well in Circuit Court. All the medical and legal documentation that I provided to him about my situation, he constantly informed me that the information did not apply to me or the case. He also informed me that he was not sure about the medical information provided.
4. This Court does have the jurisdiction over the matter based on the SC Code § 14-8-200 and the SC Const. art. V, § 9. This is an appeal from an order that was set by the Circuit Court judge to have to move from my home that is setup for me and to have to move my home because of the poor representation from the lawyer from the SC Legal Services attorney.
