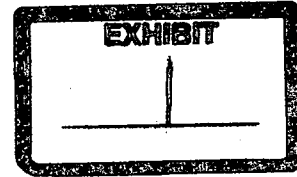

ORDER


