

Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Jamie Mishoe v. The State with the Supreme Court on July 10, 2019. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of William R. Pearson v. The State with the Supreme Court on July 8, 2019. 
4. As indicated by the counsel below, counsel for the state graciously consents to or does not oppose this request.
