


Dear Clerk:

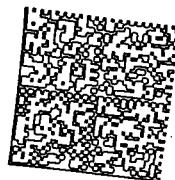
