GREENVILLE COUNTY LAND DEVELOPMENT REGULATIONS, ORDINANCE
NO. 3870, ADOPTED DECEMBER 13, 2004

Article I

1.5 Appeals

Any authorized action or decision made by the Planning Commission staff may be appealed to the Greenville County Planning Commission within fifteen (15) days. Any appeals will be scheduled for the next available Planning Commission meeting for consideration.

An appeal from the decision of the Planning Commission may be made pursuant to the provisions of Title 6, Chapter 29. [sic] taken to Circuit Court within thirty (30) days after actual notice of the decision.

Any person aggrieved by a decision of the Commission rendered after hearing may within thirty (30) days after notice thereof file an appeal in circuit court for a review of the decision of the Commission pursuant to Section 6-29-1150 of the South Carolina Local Government Comprehensive Planning Enabling Act of 1994.
