
At a Court of General Sessions, convened on January 9, 2017 the Grand Jurors of Edgefield County present upon their oath:

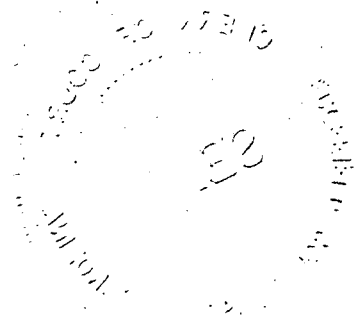
