NOTICE OF APPEAL





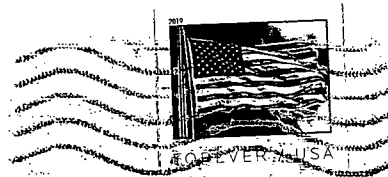
