Counsel filed the return to petition for rehearing in the case of The State v. Vladimir Pantovich with the Supreme Court on August 29, 2019. Counsel filed the brief of petitioner in the case of The State v. Robin Herndon with the Supreme Court on August 20, 2019. Counsel filed the Anders brief of appellant and designation of matter in the case of The State v. Michael Collins with the Court of Appeals on August 7, 2019


4. Counsel makes this request in good faith and not for purpose of delay.




