

On September 12, 2019, counsel filed a petition for rehearing in The State v. George Holmes with the Court of Appeals. On August 30, 2019, counsel filed the brief of respondent in The State v. Archie More Hardin with the Supreme Court. On August 27, 2019, counsel filed a petition for writ of certiorari and accompanying appendix in Michelle S. Allison v. The State with the Supreme Court. On August 26, 2019, counsel filed the petition for rehearing in The State v. Anthony M. Enriquez with the Court of Appeals.


