I **Nelson L. Bruce**, Sui Juris, Propria Persona, the Appellant/Petitioner in SC Court of Appeals Case No. 2019-001208 filed July 22, 2019 brings this complaint against **Jenny Abbott Kitchinigs** and **Claire Allen** clerks of the SC Court of Appeals for official/lawyer misconduct and breach of their oaths of office under **Article I, Section X** and **Article VI** of the **U.S. Constitution** and also **Article I Section II** of the **South Carolina Constitution**. The referenced officials have been instructing the Appellant to proceed to operate outside the law, and to violate the **supreme law of the land** and have been demonstrating misconduct and breach of their oath of office by avoiding, ignoring and not properly responding to my fee waiver, challenge to the court fees being requested by the judge and clerk of court for the **SC Court of Appeals** in order to pay corporate filing fees to a corporate entity **D.B.A. the SC Judicial Department** who has an **EIN No. of 57-6000286** evidenced by the attached **W-9 Form** provided by their **Financial Department**. This further evidences that this court by their officers and officials are operating under a corporate capacity not under the judicial government capacity as Appellant is exercising his rights to access and petition the judicial branch of government for redress of grievance, not a corporate government entity **D.B.A. the SC Judicial Department** who is currently gatekeeping and blocking access to me which as I have stated with my fee waiver request that I do not have nor possess any gold or silver coins as prescribed under the **United States Constitutional Law** which the officers and other members such as the clerks of this court have sworn an oath to uphold, preserve, protect, and defend (**ARTICLE VI SECTION 5. Form of oath of the SC Constitution**) but are breaching this oath by not upholding it which states that gold and silver is the lawful money prescribed by law to pay the restricting demands of the **SC Court of Appeals**, conditionally commanded by Officers, Employees and Contractors of the Court which the referenced officials/lawyers was notified of, evidenced by my **Affidavits of Fact** and **challenges to the court regarding filing fees** filed on the record and presented to the court and the judge on **7/22/219, 8/5/2019, 8/20/2019, and 8/29/2019**.

The referenced clerks/lawyers of the referenced court reviewed and willfully ignored and did not respond to my conditional acceptance upon proof of claims and did not provide any rebuttals to the facts presented in these affidavits but decided to dismiss my appeal stating it is being dismissed as of **9/09/2019** because the challenged **filing fee** was not paid again evidencing their misconduct and breach

of their oaths of office by continuously ignoring my proofs of claims, affidavits and neglect of the court rules to which as officials/lawyers of the referenced court who have sworn an oath, they are required to respond to, thereby tacitly acquiescing and admitting to the facts presented in that affidavit which further evidences their misconduct, breach of their oaths of office and the fact that this court by its officers and officials/lawyers refuse to follow the law, their own rules of the court, and want me to violate the law when I am trying to follow the law which the law states gold and silver is payment for any debts and fees which is supported by the constitution.

The officials of this court also is trying to inform me to file motions in order to get them to follow their own rules of the court that they are required to follow in a means to extort more money from me which is further proof of misconduct by these officers and officials of this court evidenced by the record and their continuous requests for money to enrich themselves before making any decisions on my filings. I brings forth this complaint against the referenced officials/lawyers for the reasons specified in the referenced affidavits of fact, motions, notices, conditional acceptances, and challenges to the court by me to which I incorporate by reference in its entirety in this complaint for misconduct and Breach of their oath of office.

For these reasons I bring forth my complaint against **Jenny Abbott Kitchinigs and Claire Allen** for official/lawyer misconduct and breach of their official oaths of office to which they have sworn an oath to uphold, preserve, protect, and defend the **States Constitution** and the **U.S. Constitution** to which they could not rebut the facts of which I have presented because the law states it which I am following, exercising and will continue to exercise as I have a right to.

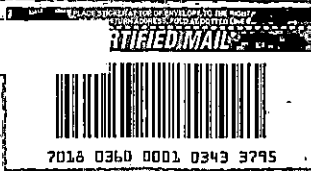

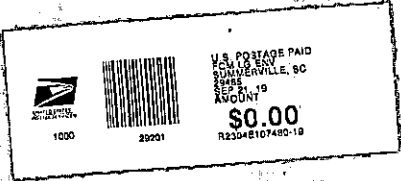
