foregoing is True and Correct.



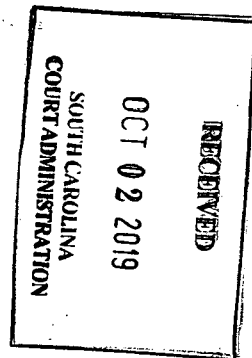
