**Second Joint Motion for an Extension of Time to File Initial  
Briefs and Designations of Matter**

Appellants Harleysville Insurance Company n/k/a Nationwide Insurance Company, Selective Insurance Company, American Empire Surplus Lines Insurance Company, Clarendon National Insurance Company, successor by merger to Clarendon America Insurance Company, Crum & Forster Specialty Insurance Company, First Mercury Insurance Company, BITCO General Insurance Corporation, Hartford Fire Insurance Company, and Hartford Casualty Insurance Company (the “Insurers”) respectfully request a 30-day extension of time to file their Initial Briefs and Designations of Matter in the above-captioned consolidated appeal. This is the Insurers’ second request for an extension of time.

The Insurers intend to file one Joint Initial Brief and Designation of Matter.<sup>1</sup> The Insurers’ counsel have coordinated efforts and are in the process of revising a draft of their joint brief at this time. The additional extension will allow the Insurers time to review, approve, and finalize the Joint Initial Brief and determine all items necessary for inclusion in the Designation of Matter. Based on the Court’s September 9, 2019 letter, the Insurers’ Initial Briefs and Designations of Matter are currently due on November 4, 2019. With the second 30-day extension request, the new deadline would run through December 4, 2019.

Therefore, the Insurers request that the Court enter an order extending the deadline for their two initial briefs and designations of matter through December 4, 2019. The Insurers request that the current deadline be held in abeyance while the Court considers this request.


