NOTICE OF APPEAL

Eugene Washington appeals his conviction and sentence in this case. The sentence was imposed by the Honorable William P. Keesley on October 24, 2019. Eugene Washington was convicted by entering a guilty plea on October 24, 2019. The court ordered the following: on case number 2019A3210200595: five years in the South Carolina Department of Corrections ("SCDC"), on case number 2019A3210700083: seven years in SCDC, on case number 2019A3210200579: five years in SCDC, and on 2019A3210200594 a five year sentence suspended upon time served, with probation for five years and ordered restitution in the amount of Eight Hundred Dollars (\$800). Each of the sentences for active time were ordered to run concurrently, and with the probationary sentence to run consecutive to the active time. The court further stipulated that probation could terminate upon full repayment of the restitution amount.



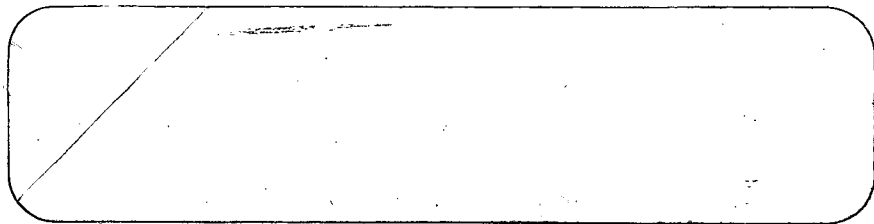
