APPELLANT'S MOTION TO HAVE THE
APPELLATE RECORD FURNISHED WITHOUT CHARGE

To the Honorable Judge of Said Court:

Comes now, Stephanie Irene Greene, Defendant in the above-entitled and numbered cause, and pursuant to the Rules of Appellate Procedure, asks this Court to have the appellate record furnished without charge, and in support thereof would show unto the Court as follows:

I.

Defendant was sentenced on April 1, 2014, in the above referenced case number to 20 years imprisonment for Homicide by Child Abuse, 5 years for Involuntary Manslaughter, and 5 years for Unlawful Neglect to be served concurrently.

II.

Defendant filed Notice of Appeal on April 10, 2014.

III.

Defendant cannot pay or give security for the appellate record, and requests that the court order the reporter to transcribe all of the proceedings in this case and to furnish the reporter's record without a charge to the defendant/appellant.

IV.

Defendant is preparing to challenge his conviction and sentence in a habeas corpus writ, and requires the reporter's record to establish the merits of her case. Without this reporter's record, defendant will be greatly prejudiced.

V.

Defendant/Appellant is widowed and does not own any interest in real property and does not have sufficient cash on hand, or in a bank, or any other assets to pay the cost of the reporter's record.

VI.

WHEREFORE, the Defendant/Appellant prays that this motion be granted, and that the Court order the Official Court Reporter to transcribe all of the proceedings in this case and to furnish the appellate record without charge to the Defendant/Appellant.

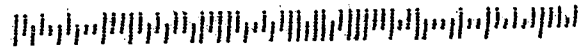
