
Dear Mr. Edwards:

To Whom It May Concern:

Mr. James H. Price III presented to Duke University Hospital on August 12, 2019 for his lung transplant evaluation. At the time of his clinic visit he was found to require up to 70L via high flow cannula with movement and was admitted immediately to the hospital. Mr. Price was listed for bilateral lung transplantation with PFO closure on August 15th and then transplanted on August 22nd after suitable organs were identified.

Although Mr. Price no longer requires mechanical support, he remains in Intensive Care at this time. We anticipate he will need several weeks of care in the hospital and then he will discharge locally in the Durham area. All lung transplant recipients at Duke are required to attend daily pulmonary rehabilitation and weekly clinic visits. It is impossible to predict when he will be ready to relocate home but he will not be cleared to return to work for a minimum of 6 months to one year.
